

All that certain lot, piece, parcel or tract of land situate, lying being in the State of South Carolina, and County of Greenville, in Greenville Township, being several tracts described, respectively as follows, to-wit:

(1) That tract about two and one half miles southwest of the City of Greenville, on the Easley Bridge Road and White Horse Road, containing 243.15 acres more or less. This is the same tract of land on which Mrs. Carolina Y. Cooper gave to The Mutual Benefit Life Insurance Company a mortgage dated March 10, 1912, and recorded in the office of the R.M.C. for said County and State in Mortgage Book #2 page 400, containing 1344.92 acres, except for 1.77 acres thereof conveyed by her to W. D. Earle by deed dated June 5, 1925 and recorded in said office in Book 18 Page 52, except Lots nos 37, 39 and 40, which were sold and released from the Plaintiff's mortgage.

(2) Those two lots conveyed to W. J. Cooper by H. J. Harris by deed dated April 13, 1919 recorded in said office in Book 50, page 95, one of said lots measuring 240 feet by 180 feet, lying on the northeast corner of the Easley Bridge Road and Washington Avenue (sometimes called the New White Horse Road) and including the lot on which a gasoline filling station has been erected recently; the other of said lots, measuring 240 feet by 200 feet, lying on the southeast corner of said roads and including the lot on which a cotton gin is situated.

(3) That lot known as Lot no 13 in Block "B" of City View, as shown on Plat Book "A" at Pages 460 and 461, fronting 50 feet on the west side of W. M. C. A street 150 feet deep, being the same lot conveyed to W. J. Cooper by B. N. Glazebrook by deed dated January 4, 1923, and recorded in said office in Book 87, Page 203.

(4) Those lots situate on the northwest side of the Easel of Bridge Road about three miles southwest of the City of Greenville, known as lots numbered 37, 38, 39 and 41 on R. E. Dalton's plat of the J. R. Young property. These are the same lots conveyed to Wm. J. Cooper by Miss Julia D. Charles, as Trustee, by deed dated December 6, 1923, and recorded in said office in Book 76, at page 251. Sale made subject to the prior mortgage thereon now owned by H. C. Bauble, recorded in the R. M. C. Office for Greenville County, in Mortgage Vol III, Page 28.
