All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, about one mile from the incorporate limits of the City of Greenville, near the Paris Mountain Road, containing one half acre, more or less, and having the following metes and bounds:

Beginning at an iron pin on the north side of the road leading to the Society Grounds, and running thence with Society Grounds N. 19 W. 128.7 feet to iron pin in line of W. H. Irvine; thence with Irvine line S. 71 W. 165 feet to iron pin; (which pin is 165 feet from cedar tree); thence S. 19 E. 129.6 feet, more or less, to iron pin in road leading to Society Grounds; and thence with said road N. 70 E. 165 feet to the beginning corner.
