Know All mon by these presents: That the undersigned, of said County and States.

hereinafter called Grantor, for and in consideration of the bergs, conditions and privileged hereinafter expressed, and the sum of one (31.00) Dollar to the Grantor in hand paid by PARKER Water and Sewer Sub-District, of Grantelle, South Carolina, the receipt whereof to hereby acknowledged, do hereby grant unto the said Grantee, its successors and assigns, the right, privilege and easement to go in and upon that tract or lot of land situate in Grantelle Township, in said County and State, and described as follows:

Bounded by Lands of Mrs. Lorena ayera, Estate of Dr Jurman, Reidmont and northern Railway Company, and the Jurman Road.

and to construct, maintain in and upon and use in and through said premises, in a preparament, with necessary apparatus and appliances such as machinery, air vents, manholos, blos-off cornections and any and every other necessary and proper attachment, pipe lines, for water and secretage purposes through the premises above described, together with the right at all times are enter in and upon said promises for the purpose of inspecting and making necessary repairs and alterations of said line, together with the right to cut away and knop clear of said pipe lines all trees and other obstructions that may in any way endanger the proper operations of same.

It is theerstood and agreed; that the easement here in granted shall extend throughout the property of the Granter about \(\frac{450}{600}\) feet, and shall be of euch width as the Grantes shall deem necessary for the purposes herein specified, and that the damage for which said Grantee may be held liable shall be confined to that arising from the use of this strip only, and nothing beyond.

It is further agreed and understood; That this easement is to be used only during the construction or repair of said pipe lines and with the exception of the right of the Grantes, its successors and assigns, against agents, servants, and employees to inspect said pipe lines and to enter at any point and make repairs, the Granter has the right to cultivate and use the land; provided, however, that this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches underground.

It is further agreed: 'hat, as a part of the consideration hereof, the Grantor herein and the heirs and assigns of the same, may make taps or connections with said pipe lines bearing the expense thereof, provided, however, that such connections or taps be made only under the rules and supervision of the engineers representing the Grantee, its successors and assigns.

It is further understood and agreed: That in case of finther future damage to crops or property due from accident in said pipe lines, the Grantee shall pay reasonable damage thereofor.

The payment and privileges above specified are hereby accepted in full settlement of all claims and damages for said easement.

All other terms and conditions of this Grant of Easement are as follows:
