Know all was by these presents: That the undersigned, of maid County and Stabe, hereinafter called Grantor, for and in consideration of the terms, conditions and privileges hereinafter expressed, and the sum of One (31.00) Hollar to the Grantor in hand paid by PARKER! where and Sawer Sub-District, of Granville, South Carolina, the receipt whereas is hereby acknowledged, do hereby grant unto the said Grantee, its successors and assigns, the right, privilege and essement to go in and upon that tract or lot of land situate in Granter wills Township, in said County and State, and described as follows: LA located on McCarolina, Street, Elizabeth Heights, a located Street.

and to construct, maintain in and upon and use in and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents, manholes, blow-off connections and any and every other necessary and proper attachment, pipe lines, for water and sewerage purposes through the premises above described, together with the right at all times to enter in and upon said premises for the purpose of impacting and making necessary repairs and alterations of said line, together with the right to cut away and keep clear of said pipe lines all trees and other obstructions that may in any way endanger the proper operations of same.

The is understood and agreed. That two casement merein granted shall extend throughout the property of the Grantor about 67 feet and shall be of such width as the Grantoe shall deem necessary for the purposes herein specified, and that the damage for which said Grantee may be held lighle shall be confined to that arising from the use of this strip only, and nothing beyond.

It is further agreed and understood: That this easement is to be used only during the construction or repair of said pipe lines and with the exception of the right of the Grantee, its successors and assigns, agents, servants, and employees to inspect said pipe lines and to enter at any point and make repairs, the Granter has the right to cultivate and use the land; provided, however, that this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches underground.

It is Further agreed: That, as a part of the consideration hereof, the Grantor herein and the heirs and assigns of the same, way make taps or connections with said pipe lines bearing the expense thereof, provided, however, that such connections or taps be made only under the rules and supervision of the engineers representing the Grantee, its successors and assigns.

It is Further understood and agreed; that in case of future damage to orops or property due from accident in said tipe lines, the Grantee shall pay reasonable damage therefor.

THe payment and privileges above specified are hereby accepted in full settlement of all claims and damages for said easement.

All other terms and conditions of this Grant of Essement are as follows:
