Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Twenty and 09/100 (\$20.09) Dollars to me paid by the said grantee M. A. Richards have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee M. A. Richards their heirs and assings:

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining,

To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said M. A. Richards his heirs and assings, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
