All that certain piece, parcel or tract of land in Bates Township, County of Greenville
State of South Carolina, being the same tract of land to J. H. Green by G. W. Bishop, and having
the following metes and bounds, to-wit:

Beginning on a stone on the East side of the Buncombe Road and running thence S. 68 E.
1933 to an iron pin; thence N. 2 1/2 W. 3.50 to a stone nm; thence N. 71 1/2 W. 19.30 to a stone in
Buncombe Road; thence S. 15 3/4 E. 2.50 to the beginning corner, containing 5 acres, more or less.

Also all that other certain piece or tract of land on Cat Tail Branch waters of Enoree
River, about 11 miles north of Greenville County Court House, S. C. on both sides of Buncombe
