I, Mrs. Ella Southern, for and in consideration of the sum of \$250.00 to me in hand paid by Henry A. Southern (the receipt whereof is hereby acknowledged, enter into the following agreement:

- 1. The said Mrs. Ella Southern does hereby release the said Henry A. Southern, her husband, from any and all liability to provide her with support and maintenance, and relinquish all claim as heir at law and dower rights in or to any and all property now owned or hereafter acquired by the said Henry A. Southern; and agrees to institute no proceedings, either civilly or criminally, against the said Henry A. Southern in respect to any of said matters, and hereby consents for the warrant now pending to be dismissed;
- 2. It is agreed that the said Ella Southern shall have the custody of the children of the parties hereto, subject to any order hereafter passed in respect thereto by the county or circuit courts of Greenville County, with the right to the said Henry A. Southern to visityand to receive visits from said children at any and all reasonable times; and the said Henry A. Southern agrees to pay to the said Ella Southern on the first of each month a sum not less than \$15.00, nor more than \$30.00, dependent upon his income and ability to pay, for the support and maintenance of said children. Said payments to be made to the Clerk of Court for Greenville County, and in event the parties do not agree on the amount within the limits aforesaid, either party may apply to either of the courts aforesaid for an order determing the amount;
- 3. The household furniture, goods and furnishings, shall be divided between parties hereto in equal shares, through agreement between themselves or their representatives, and in event said property can not be so satisfactorily divided, then Jones Clement, Deputy Sheriff, is hereby designated to make said division, and whose findings shall be final.

The parties hereto agree to live separate and apart from each other, and to refrain from any molestation or interferance with each other, and to prevent any such action on the part of others in so far as they are able to do.
