ARTICLES OF AGREEMENT.

This Agreement, Made and entered into, this the 20th day of December, 1937, by and between James W. McKinney and his wife Mary A. McKinney, of the County of Philadelphia State of Pennsylvania, parties of the first part, and James L. Simpson of New York City, party of the second part:
