in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Greenville Steel and Foundry Company, their Heirs and assigns forever,

All those two tracts pieces, parcels or lots of land in

described as follows:

Tract No. 1: All that certain tract of land bounded on the north by the right-of-way of the P. & N. Railway; on the east by Edwards Road, on the south by right-of-way of Southern Railway, and on the west by property of Greenville Nursery, containing approximately 9.80 acres, more or less, and described as follows:

Beginning at a point on Edwards Road, where the same intersects with the southern line of the right-of-way of the P. & N. Railway, and running thence in a northwesterly direction a along the southern line of said right-of-way to a pin in line of property of Greenville Nursery; thence in a southwesterly direction with the line of said property to an iron pin on the northern line of the right-of-way of the Southern Railway; thence with the curve of the northern line of said right-of-way to an iron pin where the said right-of-way crosses Edwards Road; thence in a northwesterly direction with the western side of Edwards Road approximately 407 feet to the beginning corner.

Tract No. 2: Also all that other certain piece, parcel or tract of land on the east side of National Highway No. 29, being shown and designated as Lot No. 2 on plat of the property of W. S. Edwards made March 19th, 1934 by J. E. Freeman, Surveyor, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin at the corner of Lot No. 1 on National Highway No. 29, and running thence with the line of said lot, S. 39 E. 264 feet to an iron pin on the right-of-way of the P. & N. Railway; thence with said right-of-way, N. 57-3/4 E. 105 feet to an iron pin, corner of Lot No. 3; thence with the line of said lot, N. 39 W. 274-1/2 feet to an iron pin on the eastern side of National Highway No. 29; thence with the eastern side of said National Highway S. 51 W. 105 feet to the beginning corner, less, however, the strip of land deeded to the State Highway Department by W. S. Edwards to widen the highway right-of-way. This is the same lot of land conveyed to W. S. Edwards by John V. Bishop by deed dated June 11th, 1938, recorded in the R. M. C. Office for Greenville County in Book of Deeds "204" at page 154.
