TITLE TO REALESTATE

The lessor hereby leases and demises unto the said lessee all that farm and lands in Dunklin towhship, in the County of Greenville and State of South Carolina, known as the Frank F. Stokes place or farm, and bounded and described as follows, to-wit:

Lands of G. Hart, E. A. Knight and J. W. Page on west, South E. A. Knight, East by other lands of E. A. Knight and Augusta Road.

excepting and reserving, however, out of this demise all timber and other trees, and the right to enter and cut and remove the same.

To have and to hold the said premises, except as hereinbefore and hereinafter stated, unto the lessee, for the term of one year years from the date of these presents, to-wit:

From the 1st day of Jan. A. D. 1939, to the 31st day of December, A. D. 1939, yielding and paying therefor during the said term, the \_\_\_\_\_\_\_ rent of Twenty four hundred pounds good middling cotton, clear of all deductions, in manner and at time as follows:

On or before October 15 1939 at some nearby market.

And the lessee hereby covenants with the lessor that the lessee will pay the rent. in all respects as hereinbefore stipulated and agreed, without defalcation or any delay; that the lessee will keep the said farm-house and buildings, and all things in and about the same, and all fences, ditches, frains, watercourses, gates, fixtures, and things upon or about the said farm and lands, in good condition and complete repair, and without any alteration, except such as the lessor shall approve of in writing; and shall cultivate, fertilize, manure and manage the said farm and lands in a fair and proper manner, according to the most approved course of husbandry; that he will, at the expiration, or sooner determination of the said term, yield up the said premises in such good condition and repair, and in fair and proper order, as aforesaid, unto the lessor; and that the lessor, and his agents, surveyors, and workmen, may at all reasonable times during the said term enter upon the said premises to inspect the same, and to cut and remove timber and other trees; lessee will not assign or underlet the said premises, or any part thereof, without the consent in writing of the lessor: Provided always, that on any breach of any of the covenants by the lessee herein contained, the lessor may re-enter upon the said premises, and immediately thereupon the said term shall absolutely determine.
