All that piece, parcel and lot of land in Greenville Township, and County, State of South Carolina, known as Lot No. 2 of Fride & Patton Land Company, recorded in the office of R. M. C. for Greenville in Plat Book "E" page 249, described as follows:

Beginning at an iron pin on the north side of Judson Road, Corner of Lot No. 1, and running thence with line of said Lot N. 36-15 E. 211 feet to iron pin, corner of Lot No. 44, 43 & 1; thence with line of Lot No. 43, N. 53-45 W. 60 feet to an iron pin, corner of Lots No. 43, 42 and 3; thence with line of Lot No. 3 S. 36-15 W. 211 feet to iron pin on Judson Road; thence with Judson Road S. 53-45 E. 60 feet to the beginning corner.

Also strip of land adjoining the lot above described ten feet in width taken from the west side of Lot No. 1 on said Plat, with a depth in parallel lines of 211 feet.


