TITLE TO REALESTATE

POWER OF ATTORNEY

We do further authorize our said attorney, T. Q. Donaldson, upon the sale of any lot or lots by him made, to accept as little cash as he may deem advisable and to accept in his name, as Attorney, a mortgage securing the balance of the purchase price.

Donaldson, given, made or done for the aforesaid purposes shall be as good, valid and effectual to all intents and purposes what soever as if the same had been signed, sealed delivered, given, made or done by us, in our own proper persons; and we hereby undertake at all times to ratify whatsoever our said attorney shall lawfully do or cause to be done in or concerning the premises by virtue of these presents.
