Tippett all that certain lot, piece or parcel of land situate, lying and being in said state and county, in Greenville Township, about three miles northwestward from Greenville Court House, having the following metes and bounds, according to a survey and sketch made by R. E. Dalton on November 1, 1938, to wit: beginning at an iron pin which is N. 46-10 E. twenty-seven (27) feet from the iron pin marking the west corner of the lot of land 317 by 300 feet mortgaged to The Prudential Insurance Co. of America by indenture recorded in the office of the Register of Mesne Conveyance for said county in book 219, at page 6, and running thence along rear line of said mortgaged lot N. 46-10 E. ninety (90) feet to an iron pin; thence N. 43-50 W. two hundred and eighty and 4/10 (280.4) feet to an iron pin on the boundary line of the land conveyed by Piedmont Savings & Investment Co. to Alfred Tanner by deed dated May 5. 1906, and recorded in said office in book "mmm." at page 683; thence along said Tanner line S. 14 W. one hundred and six (106) feet to an iron pin (which is 89 feet from a corner at which said boundary line runs 5.28-15 W. along the said Tanner tract); thence S. 43-50 E. two hundred and twenty-four and 2/10 (224.2) feet to the beginning corner; this being a portion of the land conveyed to me by L. O. Patterson by deed dated March 17, 1938, and recorded in said office in book 206, at page 357; subject to the restrictions stated in the deed to said L. O.
