All that certain piece, parcel or lot of land on the east side of 9th Avenue in
Judson Mills No. 2 Village, in the County of Greenville, State of South Carolina, being known
and designated as Lot No. 8 of Block F as shown on a plat of Judson Mills No. 2 Village made
by Dalton & Neves, Engineers, in March, 1939, which plat is recorded in the R. M. C. Office

an iron pipe, joint corner of Lots No. 8 and 9; thence with the line of Lot No. 9, N. 8-43 W.
