Beginning at a stone on the east side of Buncombe Road and runs thence South 73° W. 37 poles to a point on a stone; thence S. $17\frac{1}{4}^{\circ}$ East 22 poles to a rock; thence North 72° East 34-3/4 poles to the Buncombe-Hendersonville road; thence with the said road to the Beginning, containing 5 acres more or less.
