

(3) That the above described lots shall be used for no other purpose than the maintenance of a church by the grantee herein and a parsonage in connection therewith.

(4) That the above described lots shall not be sold, leased, mortgaged or otherwise conveyed by the grantee, its successors or assigns to any individual, corporation, association or group of individuals, except with the consent in writing of the grantor, its successors or assigns.

It is understood and agreed that should the grantee, its or their successors or assigns violate, or make a formal attempt to violate either or both of the foregoing restrictions numbered (3) and (4), the land herein conveyed shall immediately revert to the grantor, its successors or assigns without the necessity of re-entry.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

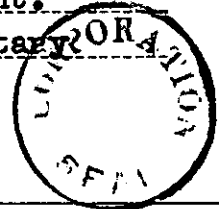
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee (s) hereinabove named, and their successors and assigns forever. but if any of the restrictions hereinabove set forth, numbered (3) and (4) shall be broken or violated by the grantee, its or their successors or assigns, or a formal attempt made to violate either or both of them, then the above mentioned premises shall immediately and automatically revert to the grantor, its successors or assigns.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and their successors and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Greer, Jr., as Secretary, on this the Twentieth day of May, in the year of our Lord one thousand nine hundred and forty, and in the one hundred and sixty fourth year of the Sovereignty and Independence of the United States of America.
