All that parcel, tract or lot of land, lying on northwest side of a road leading from the Parker Road at the J. P. Griffin place up the southwest side of Piney Mountain in the direction of the old Cuttino home, being in Chick Springs Township, County and State aforesaid, and having the following metes and bounds:

Beginning at iron pin in a gully on the Tom Raines line; thence up said gully N. 49 1/4 E. 59 1/2 of a chain to I. P. in said gully, thence S. 42 E. 4.22 chains to I. P. on southeast bank of a gully at above named road, thence with said bank of gully, S. 34 1/4 W. .60 of a chain to I. P. on same bank of gully; thence N. 42 W. 4.40 chains to the beginning corner, and containing a quarter (.25) of a acre, more or less, according to survey made by J. Earle Freeman, Sept. 16, 1940.

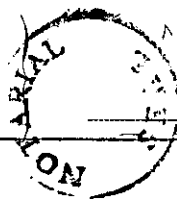
