(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Leonard Brewer, his heirs and assigns forever:

An undivided one-half interest in and to:

All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, and being the southern eleven acres from the 22 acre tract conveyed to W. D. Hudson and Leonard Brewer, and being described as follows, to-wit:

Beginning at a stake on road, at branch, corner of the 11-acre tract of W. D. Hudson, and running thence along the line of said road, and along Hudson's line, N. 33-15 E. 2.92 to a bend; thence still with said road, N. 1 E. 2.66 to Hudson's corner; thence N. 63-20 W. 8.50 to stake; thence along the line of property of Lee P. Ramsey, S. 74-45 W. 2.31, more or less, to a stake; thence S. 4-55 W. 14.01 to a stake on the north side of road; thence along the line of said road, S. 71. 3/4 E. 1.43 to bend; thence still with said road, N. 56-25 E. 3.26 to bend; thence still with road, N. 16-45 E. 3.28 to bend; thence still with said road, N. 51 1/2 E. 2.77 to the beginning corner, Being the southern 11 acres of the 22-acre tract conveyed to Leonard Brewer and W. D. Hudson by W. T. Bridges by deed dated August 15, 1936 and recorded in the R. M. C. Office for Greenville County in Vol. 187, page 104.

Leonard Brewer conveyed his undivided one-half interest to me, the said W. D. Hudson, in the northern 11-acres of the 22-acre tract, by deed dated Oct. 28, 1937, and recorded in Vol. 200, page 289, at which time I, the said W. D. Hudson, failed to convey my undivided one-half interest to said Leonard Brewer in the southern 11-acre tract, this deed being made to correct this defect, and conveys all my right, title and interest in the above described tract.
