All that certain piece, parcel or lot of land near the City of Greenville, in the County of Greenville, State of South Carolina, near the Augusta Road School on the south side of Argonne Drive and being known and designated as Lot No. 29 of the C. B. Martin Sub-division as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book F at page 102, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin, joint corner of Lots Nos. 28 and 29 and running thence S. 48°50' W. 180 feet to an iron pin, joint corner of Lots Nos. 28, 29, 30 and 39; thence S. 41°10' E. 71 feet to an iron pin, joint corner of Lots 29, 30, 37 and 38; thence N. 48°50' E. 180 feet to an iron pin on Argonne Drive; joint corner of lots Nos. 29 and 30; thence N. 41°10' W. 71 feet to beginning.
