County, S. C., in Plat Book D at page 268, and said addition having been made by Dalton & Neves,
Engineers, in November, 1939, and recorded in the R. M. C. Office for Greenville County, S. C.
in Plat Book D at pages 312 and 317, and having, according to said plat, the following metes

and 54, and running thence with the line of Lot No. 54, N. 73-25 E. 140 feet to an iron pin in
