TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against S. S. DeShields

defaulting taxpayer of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said S. S. DeShields tax defaulter, the sum of Seventeen & 41/100 dollars including the penalties on said tax execution(s) for the year(s) 1927, 1931, 1932, 1933 and 1934

together with charges and costs thereof; and Whereas, by virtue and authority of said warrants W. A. Hopkins the delinquent tax collector of the State and County aforesaid, did on the 5th day of May 1936 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of July during the usual hours of sale, after due advertisement, sell the same to The Forfeited Land Commission and their successors or assigns, the purchaser(s), hereinafter known as "grantee(s)," and the highest bidder at such sale, for the sum of Seventeen & 41/100 dollars and gave a receipt for said purchase money to them; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore, Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Seventeen & 41/100

Dollars to me paid by the said grantee(s), The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), The Forfeited Land Commission their assigns, successors or

All that lot, piece or parcel of land beginning at a stake at the intersection of Lanford Street and Barbare Ave. on East side of Lanford Street and running thence along Barbare Ave. S. 87.50 E. 141 feet to a stake; thence 2/10 E. 100 feet to a stake; thence N. 87.50 W. 139 feet to a stake on Lanford Street; thence along said street S. 3.20 W. 100 feet to the beginning corner; being all of lots number 69 & 70 on the plat of land known as the Westmoreland Circle.

Also all that other piece parcel or lot of land and having the following metes and bounds, to-wit: Beginning at a stake on East side of Lanford Street and running thence N. 87.50 W. 135 feet to stake on Lanford Street, thence along said street S. 3.20 E. 100 feet to the beginning corner, being all of lots number 73 & 74 on the plot of land known as the Westmoreland Circle.
