near the City of Greer.

Beginning at an iron pin on Lanford Street and runs thence with the said street N. 3-20 E. 142.5 feet to an iron pin; thence N. 87-50 W. 190 feet to an iron pin on Brannon Street; thence with Brannon Street S. 13-00 W. 15 feet to an iron pin on Bennett Avenue; thence with the said Bennett Avenue 225.5 feet to the beginning corner, and being known as lot No. 58 on Plat of Westmoreland Circle.

Also all that other lot of land situate, lying and being in the State and County aforesaid, near the City of Greer.,

Beginning at an iron pin on Lanford Street and runs thence with the said street N. 17-40 E. 99.3 feet to an iron pin on Bennett Avenue; thence with the said Bennett Avenue West 227 feet to an iron pin on Brannon Street; thence with the said Brannon Street S. 13-00 W. 170.1 feet to an iron pin, corner of lot No. 40; thence S. 62-20 E. 202 feet to Lanford Street, the beginning corner, and being lots 41 and 42 as shown on Plat of Westmoreland Circle.

Also all that other certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, near the City of Greer, in Chick Springs Township, and having the following courses and distances, to-wit:-

Beginning at a point on an unnamed Street and runs thence N. 78-35 W. 128.6 feet to an iron pin; thence N. 78-35 W. 241.4 feet to an iron pin, corner of lot No. 16; thence N. 11-15 E. 151 feet to an iron pin on line of A. B. Groce Estate (formerly Mrs. Morrow); thence S. 67-55 E. 242.3 feet to an iron pin; thence S. 67-55 E. 135.4 feet to an iron pin on said unnamed street (now Brannon Street); thence S. 13-20 W. 79 feet to the beginning corner, and being all of lots 19 and 46 as shown on Plat called Brookville, property of E. D. Green, said plat prepared by R. E. Dalton Eng. December, 1915.

Also all that other certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, near the City of Greer, and having the following courses and distances, to-wit:-

Beginning at a stake S. E. corner of J. L. Lanford's lot and running thence S. 13-20 W. 60 feet to an iron pin; thence N. 78-35 W. 370 feet to an iron pin, corner of F. B. Haigler and R. C. Hice's lots; thence N. 13-30 E. 60 feet to an iron pin, corner of J. L. Lanford lot; thence S. 78-35 E. 370 feet to the beginning corner, and being a part of the same land conveyed to F. B. Haigler by W. R. Few by deed dated Dec. 23rd. 1920.
