NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That Board of Trustees of Greenville School District 17A, Greenville County, for and in consideration of the provisions of the Acts of the General Assembly above referred to and the further consideration of \$1.00 in hand paid to the grantor herein at and before the sealing and delivery of these presents, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Teachers' Retirement Board of School District 17A, Greenville County, the following real estate;

Tract No. 1: All that piece, parcel and lot of land situate, lying and being in the corporate limits of the City of Greenville, County of Greenville and State of South Carolina, on Pendleton Street, House No. 1318, fronting 102 feet on Pendleton Street, and having a depth of 200 feet, said lot adjoins lot of Walter L. Patton on the East; George W. Sirrine on the West and Walter L. Patton and Addie R. Ansel on the North, and known as the Turner house and lot, Being the same conveyed to Sinking Fund Commission, School District 17A, Greenville County, S. C., by E. Inman, Master, by deed dated March 13, 1941, and recorded in Deed Book 232, page 165, R. M. C. Office for Greenville County.
