All that plot or lot of land situate and being in Springwood Cemetery City of Greenville, County and State aforesaid, Said lot being described as Lot Number 584 on Revised map of Springwood Cemetery or transcribed by W. A. Edens, C. E. bounded by lot of W. S. Grady, and others, the same being the Lot refered to in the above stated resolution of said Church and which lot is now in possession of the said Mary I. Townes and Alex S. Townes.

Together with all and singular the rights, members, Hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

To Have and to hold all and singular the said premises before mentioned unto the said Mary I. Townes and Alex S. Townes their heirs and assigns forever. And I do hind myself as Treasurer of said Church and my successors in office and said Church as far as I have or may have authority to so bind- to warrant and forever defend all and singular the said premises unto the said Mary I. Townes and Alex S. Townes, their heirs and assigns against myself as Treasurer of said Church, my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Witness my official signature and seal this first day of September in the year of our Lord one thousand nine hundred and one and in the hundred and twenty-sixth years of the Independence of the United States of America.
