KNOW ALL MEN BY THESE PRESENTS, That, H. H. Willis, in the State aforesaid, in consideration of the sum of Three Thousand Five Hundred (\$3500.00) Dollars to me in hand paid at and before the sealing of these presents by N. O. McDowell, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said N. O. McDowell,

"All those certain pieces, parcels or tracts of land in Greenville Township, County of Greenville, State of South Carolina:

Tract # 1: All that piece, parcel or lot of land in Greenville Township, County and State aforesaid, being outside the corporate limits of the City of Greenville, being about two miles from the Courthouse on Cox Bridge Road or Pickens Road, and described as follows:
