to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto V. L. Kinsey

All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 7 on Plat of Property of H. G. Stevens made by W. J. Riddle, Surveyor, April 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book M, page 9, and having the following metes and bounds, according to said Plat: Beginning at a stake on the Mountain Creek Road, at corner of Lot No. 6 on said plat, and running thence with Mountain Creek Road N. 45-15 E. 43 feet; thence still with said Road N. 35-30 E. 35 feet to stake at corner of Lot No. 8; thence with line of Lot No. 8 N. 50 W. 197 feet to stake at corner of Lot No. 11; thence with line of Lot No. 11 S. 51-35 W. 74 feet to stake at corner of Lot No. 6; and thence with line of Lot No. 6 S. 48 E. 221.2 feet to the beginning corner.
