about two miles West from Greer, being a portion of Lots Nos. 3 and 4 of the I. B. Bramon  
property, according to survey and plat by H. S. Brockman and alterations thereon, dated June  
15, 1943, containing 57/100 of an acre, and having the following courses and distances, to-wit:

Beginning at a point in road at crossing of spring branch, and running thence N.
