Fronting on Laurens Street 61 feet and appearing on a plat of ten lots of land in said City made by J. R. Lawrence, surveyor, and recorded in the office of the Register of Mesne Conveyances in and for said County of Greenville in Book D.D.D. of Deeds to real estate at page 1, and being designated on said plat as Lot Number Nine (9) beginning at an iron pin at the corner of Lots Nos. Nine (9) and Ten (10), being 171.75 feet from North Street and running back from said Laurens Street one hundred and six (106) feet to Lot Number Two (2) on said plat on a line between said Lot Number Nine (9) and Lot Number Ten (10) on said plat and also between said Lot No. Nine (9) and a part of Lot Number One (1) on said plat, to an iron pin at corner of lots Nos. Two (2) and Nine (9), thence 61 feet on a line between said Lot No. Nine (9) and said Lot No. Two (2) to Lot No. Eight (8), on said plat to an iron pin at corner of Lots Nos.
