All that certain strip, piece or parcel of land adjoining the northerly boundary of the present right of way of the party of the second part, for its main track running between Spartanburg, South Carolina, and Asheville, North Carolina, and situate, lying and being in Greenville County, in the State of South Carolina, approximately one and one-half  $(1-\frac{1}{2})$  miles eastwardly from the Town of TRYON, in the State of North Carolina, more particularly described as follows, to-wit:

BEGINNING at a point on the northerly boundary of the right of way of the party of the second part for its main track, 100 feet northwardly from a point in the center line of the main track, measured on a radial line from the center line, 6900 feet eastwardly, measured along the center line of said main track, as proposed to be relocated, from Milepost W-41 of the party of the second part; and running thence, WESTWARDLY, ALONG the northerly boundary of the present right of way of the party of the second part for its said main track, for a distance of 465 feet, more or less, to the point of intersection with the center line of the road or highway known as "Old Landrum Road"; thence, NORTHEASTWARDLY, along the center line of said "Old Landrum Road", for a distance of 135 feet; thence, SOUTH 70 degrees 20 minutes EAST, parallel with and 100 feet northwardly from the center line of said main track, as proposed to be relocated, for a distance of 350 feet, more or less, to the point or place of beginning.

SAID parcel of land containing 0.2 of an acre, more or less, and being located substantially as shown outlined in red color upon the attached blue print/of Drawing No. 13-102, dated December 30, 1942.
