

THE STATE OF SOUTH CAROLINA, } BY THE SECRETARY OF THE STATE.
EXECUTIVE DEPARTMENT

WHEREAS, WILLIAM D. YOUNG and DOROTHY R. YOUNG, both of Greenville, S. C.,

did on the 9th day of January, 1947, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is SKY TOP RANCH

THIRD: That the principal place of business is RFD 7, PARIS MOUNTAIN, GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is farming, breeding of horses and livestock and general agrarian activities, buying, selling and development of real estate, engaging in home and wood craft activities.

FIFTH: That the amount of the capital stock is Thirty-seven Thousand Five Hundred (\$37,500.00)

payable 20% in cash, the remainder of which has been subscribed.

SIXTH: That the number of shares into which the capital stock is divided is three hundred fifty (350) Preferred of the par value of One Hundred (\$100.00) Dollars. and 2,500 shares of the per value of \$1.00 each, of Common stock.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 8th day of January, 1947, at which a majority of all stock in value being present in person or by proxy the following were elected directors:

William D. Young, Dorothy R. Young and Nancy Lou Young

EIGHTH: That subsequently there was elected as President William D. Young

as Vice-President, Dorothy R. Young; as Secretary, Nancy Lou Young

as Treasurer, William D. Young

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont

a newspaper published in the County of Greenville

NOW, Therefore, I, W. P. BLACKWELL, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
