Know All Men by These Presents:

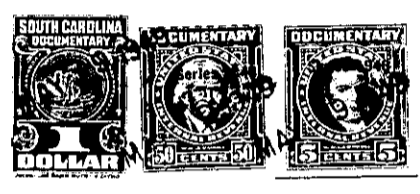
That I, W. B. McDowell in the State aforesaid, in consideration of the sum of Four Hundred and No/100- (\$400.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Will F. Jameson and Carrie G. Jameson, their Heirs and Assigns forever,

"All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being known and designated as Lot No. 19 on Plat of Property of W. B. McDowell, recorded in the R. M. C. Office for Greenville County in Plat Book S at Page 53, and having, according to said Plat, the following metes and bounds to-wit:

"BEGINNING at an iron pin on the Eastern side of Chestnut Street, at the joint front corner of Lots Nos. 17 and 19, and running thence with the line of Lot No. 17, N. 81-45 E. 212.6 feet to an iron pin; thence N. 13 W. 50.1 feet to iron pin, corner of Lot No. 21; thence with the line of Lot No. 21, S. 81-45 W. 207.6 feet to an iron pin on Chestnut Street; thence with the Eastern side of Chestnut Street, S. 8-15 E. 50 feet to the point of beginning."
