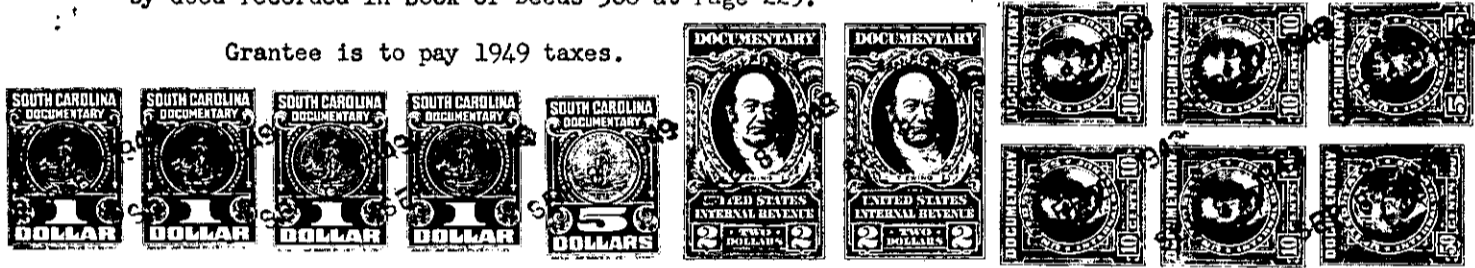
All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the Northeast corner of Wilton and Earle Streets, and running thence with Earle Street, S. 88 1/2 E. 65 1/2 Feet to an iron pin; thence N. 5 1/2 E. 150 feet to an iron pin; thence N. 84 1/2 W. 65 1/2 feet to an iron pin on Wilton Street; thence with Wilton Street, 150 feet, more or less, to the beginning corner.

ALSO all that other tract of land adjoining the above described lot and more particularly described as follows:

BEGINNING at an iron pin on the North side of W. Earle Street 65 1/2 feet from Wilton Street, thence with Earle Street, S. 83-15 E. 65 1/2 feet to an iron pin; thence N. 6-30 E. 150 feet to an iron pin; thence N. 83-15 W. 65 1/2 feet to an iron pin; thence S. 6-30 W. 150 feet to the beginning corner.
