to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe P. Murrell, his heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as a portion of lots Nos. 17 and 18, as shown on Map No. 2 of Camilla Park, recorded in Plat Book M, at Page 85, and being more particularly described according to said plat as follows:

BEGINNING at a point on the White Horse Road, 240 feet North of the Northeast intersection of the White Horse Road and Daniel Avenue; at the joint front corner of lots Nos. 18 and 19, and running thence with the joint line of said lots, S. 80-44 E. 200 feet to a point at the joint rear corner of lots Nos. 18, 19, 50 and 51, and running thence along rear line of lots Nos. 18 and 51, N. 27-40 E. 68.25 feet to a point in the center of the rear line of lot No. 51, and running thence in a Northwesterly direction through lots Nos. 17 and 18, 215 feet more or less to a point on the East side of the White Horse Road; thence with the East side of said road, S. 17-06 W. 94.15 feet to an iron pin; thence continuing with said White Horse Road, S. 9-16 W. 9.6 feet to the beginning corner.
