Know All Men by These Presents:

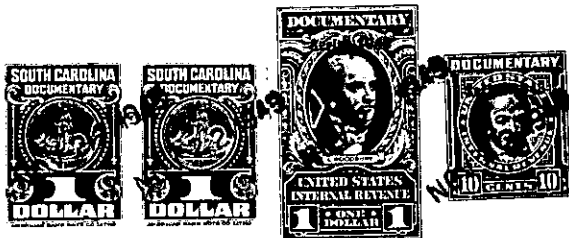

Looper and Leona H. Looper, their Heirs and Assigns forever,

All that lot of land in Gantt Township, Greenville County, State of South Carolina, on the Southern side of Monteith Circle, just outside of the City of Greenville, being shown as Lot No. 11 on Plat of Monteith Heights, made by Pickell and Pickell on March 28, 1946, recorded in Plat Book B at Page 185, and described as follows:
