Know All Men by These Presents:

That I, David G. Traxler, in the State aforesaid, in consideration of the sum of Five Thousand Eight Hundred Fifty and No/100 (\$5,850.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RUDOLPH E. DEMPSEY and BOBBIE JEANNE DEMPSEY, their heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Southern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 302, Pleasant Valley, according to plat of said Subdivision prepared by Dalton & Neves in April, 1946, including additions to said Plat through November, 1948, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P", at Page 92, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Prancer Avenue at joint front corner of Lots # 302 and # 303, said pin being 120 feet Northeast of iron pin in the Southeast corner of the intersection of Prancer Avenue with Panama Avenue; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of Lots #302 and # 303; thence S. 89-52 W. 60 feet to an iron pin at joint rear corner of Lots # 301 and # 302; thence N. 0-08 W. 160 feet to an iron pin on the Southern side of Prancer Avenue, joint front corner of Lots # 301 and # 302; thence along said Avenue, N. 89-52 E. 60 feet to an iron pin at joint front corner of Lots # 302 and # 303, the point of beginning.

The Grantees herein are to pay the 1950 taxes on the above-described property.

The above described property is subject to restrictions recorded in the R.M.C. Office, Greenville, South Carolina, in Deeds Volume 301, at Page 60, as amended in Deeds Volume 367, at Page 106.
