

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near the City of Greenville, Greenville County, South Carolina, and being more particularly described as Lot 42 Section B, as shown on a plat entitled "A Subdivision for Woodside Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and recorded in the R. M. C. Office for Greenville County in Plat Book W, at pages 111-117, inclusive. According to said plat the within described lot is also known as No. 9 West Fifth Street (Avenue) and fonts thereon 79 feet.

The granter and its predecessors in title have granted unto Parker Water & Sewer Sub-District Commission, Commissioners of Public Works of the City of Greenville, S. C., Greater Greenville Sewer District Commission, Greenville Traction Company, Duke Power Company and its predecessors Southern Power Company and Southern Relivery Company, and Fedmont and Northern Ralivery Company was the predecessor Greenville, Spartanburg and Anderson Ralivery Company, and Predmont and Northern Ralivery Company and its predecessor Greenville, Spartanburg and Anderson Ralivery Company, on one or more of them and/or to their all water and sever pipe line? There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above de scribed, and this conveyance is made subject to the rights of way and easements above mentioned insofar as they may affect said lot.

(1) That no mercantile establishment, other than those already in existence, shall be erected, operated or maintained on the lot above described.
