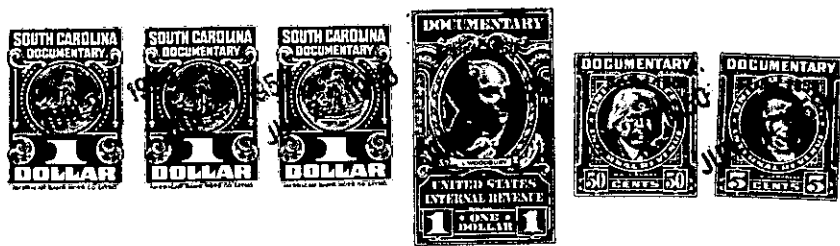
Know All Men by These Presents:

Iler and Rosalie M. Iler, their heirs and assigns, all that piece, parcel or lot of land situate lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of Brookwood Drive, being known and designated as Lots #38, #39 and #40, Block D, Stone Estates, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book G, page 292, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Brookwood Drive, joint front corner of Lots #37 and #38, Block D, Stone Estates, which iron pin is 500 feet in a Southerly direction from an iron pin in the Southwestern intersection of Reid Street and Brookwood Drive and running thence N. 78-38 W. 160 feet to an iron pin, joint rear corner of Lots #37 and #38; thence N. 11-22 E. 75 feet to an iron pin, joint rear corner Lots #10, #11, #40 and #41; thence S. 78-38 E. 160 feet to an iron pin on the Western side of Brookwood Drive, joint front corner of Lots #40 and #41; thence S. 11-22 W. 75 feet to an iron pin, the point of beginning.

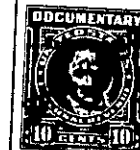
The Grantees herein are to pay the 1950 taxes on the above described property.
