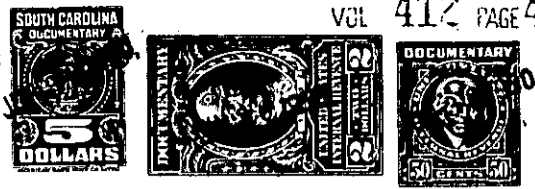

Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. L. Wilson, his heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designed as Lot No. 50 and a portion of Lot No. 49, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

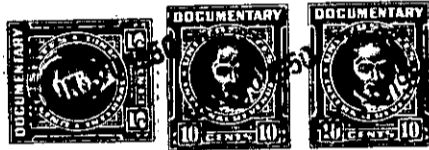
BEGINNING at an iron pin on the Southern side of Bradley Boulevard at joint front corner of Lot Nos. 51 and 50 and running thence with the joint line of said lots S37-34 E 175 feet to an iron pin on the Northern side of a 20 foot alley; thence with said alley S52-26 W 130 feet to a new point on the rear line of Lot No. 49; said point being S52-26 W 55' from the joint rear corner of Lot Nos. 49 and 50; thence in a new line through Lot No. 49, N37-34 W 175 feet to a point on the Southern side of Bradley Boulevard; thence with Bradley Boulevard N52-26 E 130 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R.M.C. Office for Greenville County in Volume 345 at page 159.

This conveyance is subject to the Restrictive covenants recorded in Volume 325 at page 11 and as amended in Volume 343 at pages 7 and 256.
