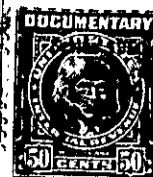
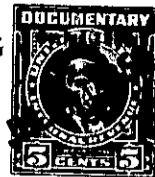

is hereby acknowledged), have granted, sold and released, and by these presents do grant, sell and release unto
E. J. DILLARD and wife Nelle W. Dillard all that piece,
parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina,
being known and designated as Lots Number Sixty-Six (66), Forty-Five (45), and Seventy-
Nine (79) of SHERWOOD FOREST as shown on a plat thereof recorded in the R. M. C. Office
for Greenville County, South Carolina, in Plat Book Y, page 23.

This deed is made subject to restrictions applicable to Sherwood Forest and recorded in the R. M. C. Office for
