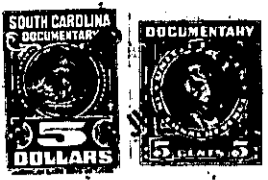

All that piece, parcel, or lot of land in the City of Greenville, County of Greenville, State aforesaid, and being known and designated as lot Nos. 34 and 35 on Plat of Rockwood Park of record in the R. L. C. Office for Greenville County, in Plat Book "S", Page 168 and 169, and being more particularly described according to said Plat as follows:

BEGINNING at a point on the north side of Rockwood Drive at the joint corners of lots 35 and 36, thence N 51-34 W 175 feet along the line of lot 36 to the rear corner thereof, thence N 38-20 E 150 feet to rear corner of lot 33, thence S 51-34 W 175 feet along the line of lot 35 to the front corner thereof on Rockwood Drive, thence along Rockwood Drive S 38-20 W 150 feet to the point of beginning, being a part of the same property deeded to us by Julia M.
