Know All Men by These Presents:

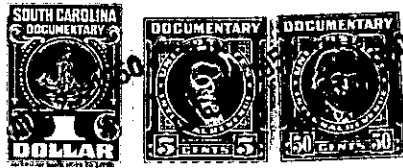
That I, M. W. Fore in consideration of the sum of ONE HUNDRED FIFTY (\$150.00) in the State aforesaid, DOLLARS,

Roma Mason all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 10 of Block "I" on a Plat of Riverside, recorded in Plat Book "A", pages 322 & 323, in RMC Office for Greenville County, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Columbia Avenue; joint corner of lots Nos. 9 and 10, and running thence with line of lot No. 9, 125 feet to an iron pin on the North side of a fifteen-foot alley; thence with said alley, 50 feet to an iron pin, joint corner of lots Nos. 10 and 11; thence with line of lot No. 11, 125 feet to an iron pin on the South side of Columbia Avenue; thence with Columbia Avenue, 50 feet to an iron pin, the beginning corner.
