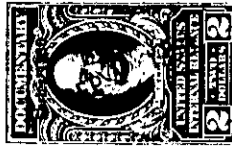

OLLIE FARNSWORTH Know All Men by These Presents: R.M.C.

That I, Sam Zimmerman, Jr in the State aforesaid, in consideration of the sum of Thirty seven hundred sixty five and 84/100 DOLLARS, and assumption of mortgage referred to below. to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gertrude S. Sloan, her heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying south of Hampton Avenue Extension and having the following notes and bounds, to-wit: BEGINNING at an iron pin at the southwest corner of lot now or formerly owned by E. O. Couch, which iron pin is 150 feet from the south side of Hampton Avenue, and running thence S. 18-45 W. 109 feet to a stake on a 10 foot alley; thence S. 80-15 E. 229 feet, more or less, along the Northern side of said alley to an old corner; thence N. 10-25 E. 69 feet to another old corner; thence along the rear line of certain lots facing Hampton Avenue Extension ... 74 ... 211.15 feet, more or less, to the beginning corner.

Together with the right and privilege to the grantee of the use of a certain alley 10 feet in width running along the Southern side of the lot hereinabove conveyed, and also the right and use to another alley 10 feet in width, which alley runs from Kelly Avenue and joins the second alley above described, and the last mentioned alley runs approximately N. 81-15 W.; it being the intention of the grantor to give the grantee all rights and privileges which he has to the joint use of said alleys running into said property from Kelly Avenue, and it is also understood and agreed that the grantee's right and privileges to the use of said alleys is subject to and in conformity with the rights and privileges of other adjacent property owners to said alleys. There is situate on the above described property five houses. The above lot is shown on the new township block book as Lot No. 12 in Block 7 on sheet 139.

This property is conveyed subject to a mortgage to the Fidelity Federal Savings and Loan Association of Greenville, S. C., in the original amount of \$4500.00, dated April 12, 1950 and recorded in the R.M.C. Office for Greenville County, S.C. in Mortgage Book 456, page 42, with an unpaid balance of \$2234.16 as of September 1st, 1950. This is the same property conveyed to me by Alexander Finley, Jr. by deed dated Jan. 1, 1948 and recorded in R.M.C. Office for Greenville County, S.C. in Deed Book 332, page 444. The grantee herein to pay taxes for the year 1950 and thereafter.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises herebefore mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
