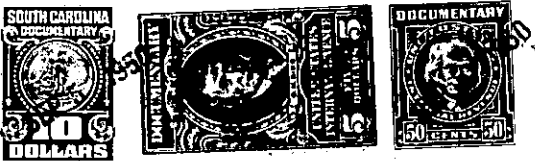
That Myrtie Corley in the State aforesaid,

BATSON, Her heirs and assigns, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the northeast corner of Florida Avenue and Peachtree Street, and being known and designated as Lot #14, Block "N", of Highland, as shown on plat recorded in the R.M.C. Office for Greenville County, in Plat Book "E", page 208, and having the following metes and bounds:

BEGINNING at an iron pin at the northeast intersection of said Florida Avenue and Peachtree Street and running thence with Peachtree Street N. 71-00 E. 133.30 feet to an iron pin, corner of Lot #15; thence with line of Lot #15, N. 9-30 W. 80 feet to an iron pin, corner of Lot #12; thence with line of Lot #12 S. 71-00 W. 142.19 feet to an iron pin on Florida Avenue; thence with Florida Avenue N. 22-10 E. 80 feet to the beginning corner.
