County State of South Carolina, being about three (3) miles North from Tiger-ville, and bounded by lands of Grady Howard, Laurence Gosnell, Saluda Land Company, John Howard and George Odam, and being the same property that was conveyed to Malinda Harrisom by Nancy Howard by deed dated November 7, 1942, recorded in the RMC Office for Greenville County in deed book 248, page 365, and being estimated in said deed as 2.5 acres, but by a survey of the same by H.
