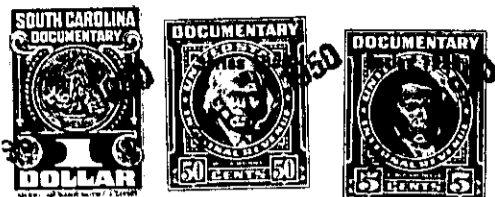

 thence N. 25-53 W., 70 feet to an iron pin, joint corner of lots  
 Nos. 58 and 59; thence with line of lot No. 59, S. 62-30 W., 168  
 feet to an iron pin on the East side of Silver Lake Drive; thence  
 with Silver Lake Drive, S. 27-30 E., 70 feet to an iron pin the  
 beginning corner.

LOT NO. 59: BEGINNING at an iron pin on the East side of Silver  
 Lake Drive, joint corner of lots Nos. 58 and 59, and running thence  
 with line of lot No. 58, N. 62-30 E., 168 feet to an iron pin; thence  
 N. 25-53 W., 70 feet to an iron pin, joint corner of lots 59 and 60;

 on the East side of Silver Lake Drive; thence with Silver Lake Drive,
