That Emily R. Bobbitt and Lake H. Bobbitt in consideration of the sum of--Twenty-six Hundred Fifty and No/100 (\$2650.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. M. Hargrove, his heirs and assigns, all those pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate on the Southern side of Wilderness Lane, being known and designated as Lot #78 and the Westerly and adjoining one-half of Lot #79, according to plat of Cleveland Forest, prepared by Dalton & Neves, Engineers, with additions to said plat made through September 1945, as recorded in the R.E.C. Office for Greenville County, South Carolina, in Plat Book "I", at page 137, and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the Southern side of Wilderness Lane at joint front corner of Lots #77 and #78; thence along the line of said lots S. 17-44 E. 150 feet to an iron pin at joint rear corner of Lots #77 and #78; thence N. 72-16 E. 95 feet to an iron pin at the center point on the rear line of Lot #79; thence through the center of Lot #79 following a straight line in a Northwesterly direction 150.15 feet to an iron pin at the center point on the front line of Lot #79 on the South side of Wilderness Lane; thence along said Wilderness Lane S. 72-16 W. 90 feet to an iron pin at joint front corner of Lots #77 and #78, the point of beginning.

The above described property is subject to restrictions recorded in the R.M.C. Office for Greenville County, South Carolina, in Volume K, at pages 47 and 90. Said property is further restricted in that no residential building built thereon shall cost less than \$6,000.00 nor be built nearer than 50 feet from the street line. Any residential building built thereon shall face onto Wilderness Lane.

The Grantee is to pay the 1950 taxes on the above described property.

This is the same property conveyed to the Grantors herein by Raymond L. Champoux and Sarah T. Champoux by deed dated September 19, 1949, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 391, page 446.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
