That I, James C. Hughes, in consideration of the sum of Five Hundred (\$500.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said B.M. Dillard and his heirs and assigns:

All my right, title and interest in and to all that certain parcel or tract of land containing Eighty (80) Acres, more or less, situated in Austin Township, Greenville County, State of South Carolina, designated as Tract No. 4 of the Property of Nancy Caroline Hughes, according to survey by W. A. Adams, Surveyor, dated September, 1914, plat recorded in Plat Book E, page 297, R. M. C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at a stone on the Greenville Road, and running thence S. 54-7/8 W. 14.35 to a stone; thence S. 47 E. 1.73 to a maple; thence S. 42 W. 2.00 to a birch; thence S. 27-1/4 W. 1.66 to a poplar; thence S. 3/4 E. 2.85 to a Post Oak; thence S. 12-3/4 W. 11.50 to a willow; thence S. 60-1/2 W. 6.50 to a stake; thence due West 6.08 to a birch; thence N. 46-7/8 W. 8.16 to a popular stump; thence N. 9-9/10 W. 10.25 to a sweet gum; thence N. 9-3/4 E. 7.40 to a stone; thence N. 26-1/2 E. 10.00 to a stone; thence N. 29-1/2 E. 10.20 to a stone; thence N. 38 W. 5.14 to a stone in Greenville Road; thence with said road, S. 77 E. 6.16 to bend; thence S. 65 E. 6.69 to bend; thence S. 71 E. 8.87 to bend; thence S. 50-1/2 E. 8.35 to the beginning corner.

The grantor is one of the children of the said William Earle Hughes, now deceased.

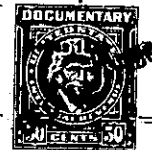
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
