to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. C. Young, his heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State aforesaid, being known and designated as Lot No. 19 according to a plat of property of P. L. Bruce, prepared by R. K. Campbell and recorded in the Office of the Register of Mesne Conveyance in Plat Book W, at page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin at the Northwest joint corner of Lots 18 and 19 and running thence along an unnamed street, N. 34-55 E. 60 feet to a point, joint front corner of Lots 19 and 20; thence along the joint line of Lots 19 and 20, S. 55-05 E. 140 feet to the joint corner of Lots 8, 9, 19 and 20; thence along the joint lines of Lots 19 and 9, S. 34-55 W. 60 feet to a point, joint corner of Lots 9, 10, 18 and 19; thence along the joint line of Lots Nos. 18 and 19, N. 55-05 W. 140 feet to the point of beginning.
