

BEGINNING at an iron pin on the north side of Buist Avenue at a point 600 feet from Rutherford Street and running thence along Buist Avenue S. 65-30 E. 100 feet to an iron pin, joint corner of Lots 16 and 17; thence along the line of Lot 17 N. 30 E. $189\frac{1}{2}$ feet to an iron pin; thence N. 65-30 W. 100 feet to an iron pin; thence S. 30 W. $189\frac{1}{2}$ feet to the point of beginning

BEGINNING at an iron pin on the north side of Buist Avenue, said iron pin being 75 feet from the joint corner of Lots 14 and 15; and running thence along Buist Avenue S. 65-30 E. 25 feet to an iron pin at the corner of Lot 16; thence N. 30 E. 1892 feet along the line of Lot 16 to an iron pin; thence N. 65-30 W. 25 feet to an iron pin; thence S. 30 W. $189\frac{1}{2}$ feet to the beginning corner.
