

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the West side of Trotter Street, and being shown as all of Lot 7 and a portion of the North part of Lot 8 on plat of Property of Jones McCrory, et al, which plat is recorded in Plat Book A, at page 151, R. M. C. Office for Greenville County, S. C., and having according to a plat of the property of John P. Batson, et al, prepared by Pledmont Engineering Service, March 7, 1951 from an original survey of same by J. C. Hill, Engineer, dated February 17, 1951, the following metes and bounds, to-wit:

BEGINHING at a point on the west side of Trotter Street, which point is N. 10-30 E. 41.1 feet from the joint front corner of Lots 8 and 9; thence along the West side of Trotter Street, N. 10-30 E. 51.9 feet to an iron pin on the Southeastern edge of the Southern Railroad right-of-way; thence along the Southeastern edge of said right-of-way, S. 69-00 W. 72 feet to an iron pin at joint rear corner of Lots 7 and 8; thence continuing along said right-of-way, S. 66-10 W. 25.7 feet to an iron pin; thence along a new course through the Northern portion of Lot 8, S. 79-50 E. 82.8 feet to point of beginning. Grantee to pay 1951 taxes.
